## About the rights of persons with 1-2 group disability

(established in lifetime)

## To exemption from payment of pension contributions at the expense of CPC

According to the Social Code of the Republic of Kazakhstan, persons with disabilities of the first and second groups are exempt from paying compulsory pension contributions (CPC) to the Unified Accumulative Pension Fund (UAPF), if the disability is established for an indefinite period. At the same time, the employer is allowed to withhold and transfer CPC to the UAPF based on the application of the above persons. Thus, Kazakhstanis who have a disability of the first or second groups, established indefinitely, have the right to submit an application at their place of work for consent to withhold CPC in the UAPF.

Persons with disabilities of the first and second groups, if the disability is established indefinitely, have the right to receive pension benefits from the UAPF according to the established schedule in the form of monthly pension payments. The UAPF, with the consent of the contributor (beneficiary), provided in accordance with the Law of the Republic of Kazakhstan *On Personal Data and Their Protection*, independently requests information on the establishment of disability from the information system of the Ministry of Labor and Social Protection of the Population of the Republic of Kazakhstan "Centralized Data Bank of Persons with Disabilities."

You can submit an application for payment of pension savings in person to the UAPF office or through an authorized person, through the Internet resource enpf.kz, as well as by post.

Please note that the UAPF also organizes on-site services for persons with disabilities of the first or second group, established for an indefinite period. In this case, a preliminary consultation is carried out, including checking the possibility of receiving services remotely, without traveling.

Consulting services of the UAPF can be obtained through messengers (chat bot on WhatsApp and Viber at +7 777 000 14 18), call center at 1418 (calls within Kazakhstan are free), on the corporate website enpf.kz, as well as on official pages UAPF on social networks Instagram, Facebook, VKontakte, Twitter, Telegram, Odnoklassniki.

The UAPF was established on August 22, 2013 on the basis of GNPF APF JSC. The UAPF founder and shareholder is the Government of the Republic of Kazakhstan represented by the State Institution "Committee of State Property and Privatization" of the Ministry of Finance of the Republic of Kazakhstan. UAPF pension assets are managed by the National Bank of the Republic of Kazakhstan. From January 1, 2016, the functions for developing proposals to improve the management of pension assets were transferred to the National Fund Management Council. In accordance with the pension legislation, the UAPF attracts compulsory pension contributions, compulsory occupational pension contributions, voluntary pension contributions, pension benefits, individual accounting of pension accumulations and benefits, provides the contributor (beneficiary) with information on the status of his pension accumulations (for more information visit www.enpf.kz)
