Be careful, there are scammers!

UAPF informs its contributors and beneficiaries about the increasing cases of fraudsters sending false information on social networks.

False intermediaries, posing as employees of the Fund, offer pensioners for a fee to receive 50% of pension savings for any purpose. This newsletter is fake and does not correspond to reality!

We remind you that the legislation of the Republic of Kazakhstan provides **for the use by pensioners of their pension savings** formed at the expense of compulsory pension contributions (hereinafter referred to as CPC) and (or) compulsory occupational pension contributions (hereinafter referred to as COPC) **in order to improve housing conditions and (or) pay for medical treatment** in case of :

➤ if the amount of the pension ensures the replacement rate of the recipient's average monthly income at a level of at least 40 percent, determined in the manner determined by the Government of the Republic of Kazakhstan. At the same time, the lump-sum pension benefit cannot exceed 50 percent of the amount of pension savings at the expense of the CPC and (or) COPC of the contributor (beneficiary) as of the date of receipt of the initial electronic notification from the authorized operator.

In this regard, the UAPF strongly recommends ignoring the messages disseminated in social networks and other sources about the possibility of withdrawing 50% of the savings for a certain fee, without taking into account the above conditions!

IMPORTANT! All transactions conducted by UAPF are free of charge!

UAPF recommends not contacting third parties and checking information only on the official website enpf.kz or the official pages of the Fund in social networks.

The UAPF was established on August 22, 2013 on the basis of GNPf APF JSC. The UAPF founder and shareholder is the Government of the Republic of Kazakhstan represented by the State Institution “Committee of State Property and Privatization” of the Ministry of Finance of the Republic of Kazakhstan. UAPF pension assets are managed by the National Bank of the Republic of Kazakhstan. From January 1, 2016, the functions for developing proposals to improve the management of pension assets were transferred to the National Fund Management Council. In accordance with the pension legislation, the UAPF attracts compulsory pension contributions, compulsory occupational pension contributions, voluntary pension contributions, pension benefits, individual accounting of pension accumulations and benefits, provides the contributor (beneficiary) with information on the status of his pension accumulations (for more information visit www.enpf.kz)
