

Pension Assets Portfolio Structure, in %





The Structure of the Pension Assets Portfolio by managing company, %




The Structure of the Pension Assets Portfolio by managing company in securities category, %



Securities accounted for at amortized cost account for 36.77% of the pension assets of the UAPF investment portfolio. The share of securities in the category of accounting assessed at fair value amounted to 56.56% of pension assets. Cash, REPO transactions, deposits, etc. make up the remaining part -6.67%.


The Structure of the Pension Assets Portfolio in Currency by managing company, %

- > PGIM Limited and Principal Global Investors (Europe) Limited under the investment grade corporate bonds mandate.


The Structure of the Pension Assets Portfolio by managing company in creditworthiness, %



Financial instruments with a minimum risk level. with a rating of securities / issuer on an international scale from "AAA" to "BBB-" make up **93.53%** of the investment portfolio. Financial instruments with a rating on an international scale from "BB +" to "B-" and the national scale "kzBB +" account for **3.63%**. Non-rated financial instruments account for **2.84%**.
